MINUTES FROM PREVIOUS MEETING August 20, 2012

Business Arising - Progress Reports

<u>Item 1:</u> **CVB Colliery and coal transportation (ongoing)** – Report by Neil from second CCC meeting (full written report available) Key points:

- a) Site inspection held, condition of mine appalling, coal used as ground cover to eliminiate erosion, whole area occupational health and safety issue, uncovered and unmarked oil and chemical containers, settling ponds for area runoff and mine discharge is leaking in many places and causing tree dieback
- b) Numerous complaints received see complaint register tab on Lake Coal's new website all complaints relating to coal trucks

Item 3: Oval amenities and Vales Point Reserve (ongoing) -

Oval amenities – **S**pring-loaded tap will be installed outside block. No definite answer yet on opening hours of disabled toilet.

Vales Point Reserve – Orange bunting around dislodged sandstone block awaiting repair by Council. Question: What exactly is Council going to do to fix the problem?

Item 4: Shared pathway (ongoing) -

- a) Letter from Minister Andrew Stoner who has spoken on Precinct's behalf to Hunter Crown Lands asking they assist us with information about Crown Land boundaries around Lake Macquarie foreshore to CVB. Meeting organised for October 26.
- b) No reponse yet from WSC seeking support-in-principle
- c) Landcare (Julie McGoldrick) expressed some concerns about the possible route of the shared pathway.

Item 5: Ruttleys Rd/Pacific Hwy intersection (ongoing) -

Traffic lights - RMS investigation still underway.

Clean-up of southern corner area where rubbish dumped – Letter sent to WSC no response yet

<u>Item 6:</u> Boat ramp repairs (ongoing) – should be finished before summer.

<u>Item 7:</u> Eaton's Hardware entry/exit on Ruttleys Rd (ongoing) – no response yet from WSC re our submission opposing alterations to clauses 9 and 36 of the original conditions of consent

<u>Item 8:</u> Boat storage on waterfront reserve (ongoing) - Draft policy is yet to go before a full Council meeting <u>Item 9:</u> WSC reclassification of community property (ongoing) - will deal with individual re-classifications as they arise <u>Item 10:</u> Mannering Colliery mining operations (ongoing) - NSW Dept of Planning is currently reviewing submissions to the Environmental Assessment for the continuation of Mannering Colliery mining.

<u>Item 14:</u> Dunvegan St drainage (ongoing) – Many complaints, strong community dissatisfaction over Council inaction, suggestion that as many residents as possible make individual Service Requests to Council to complain, Precinct take the matter up with Councillors as a key issue.

<u>Item 15:</u> Ruttleys Rd/Wyee Rd intersection (ongoing) – Lake Macquarie Council has allocated funds for this financial year and final design options being completed

Item 16: Foreshore erosion (ongoing) – Received an informal response but awaiting official reply from WSC

<u>Item 17:</u> Concept plan for central MP recreational zone (ongoing) - Awaiting reply from WSC re meeting to discuss and be advised about community consultation process to establish a concept plan

<u>Item 18:</u> Drainage on shared pathway Campbell Pde to Catherine St (ongoing) – has been repaired. Question: What was the cost of the work?

<u>Item 19:</u> Speeding on Vales Road (ongoing)— Asked WSC to place pressure strips/traffic counters on Vales Rd to gather information to support Precinct's approach to RMS. WSC is making preliminary inquiries with RMS and Council's Roads & Stormwater Unit and will advise in due course.

<u>Item 20:</u> Unsafe road crossing Campbell Parade (ongoing) – On-site meeting held and various suggestions made by WSC. Letter to WSC Andrew Pearce asking to confirm any action. No reply as yet.

<u>Item 21:</u> WSC meeting re strategic future of northern shire (ongoing) - In August WSC decided to hold a meeting to reevaluate the strategic plan for the northern shire. No reply to our letter yet asking our Precinct be involved.

<u>Item 22:</u> Children's play equipment at Community Hall (ongoing) – No reply yet to our letter to WSC asking the play equipment at the hall be replaced. Also we requested a copy of draft Playground Strategy (not presented to Council yet) indicating a District Playground being built next to hall in 2016/17. Not received as yet.

<u>Item 23:</u> Roadworks on Ruttleys Road (ongoing) – Letter sent to WSC asking they restore Ruttleys Rd to at least, or better than the condition of road before Ausgrid works. No reply yet. It is understood WSC will do works on behalf of Ausgrid.

<u>ACTION:</u> Precinct place Service Request asking WSC to repair and replace the missing white roadside marker posts and repair the long rut at the edge of the road on the straight stretch of Ruttleys Road

<u>Item 24:</u> Litter along Ruttleys Road (ongoing) - Letter sent to WSC asking for more regular litter collections. No reply yet but seems a bit cleaner lately.
